# Non-DLC Lighting Incentives Form

## Non-DLC lighting policies apply to Prescriptive & Custom projects

### Use this form if lighting *may* meet DLC criteria

Effective July 1, 2017, rules have been revised governing Prescriptive and Custom incentives granted to lighting not listed by the DesignLights Consortium® (DLC) on its website — [designlights.org/QPL](http://designlights.org/QPL):

**Prescriptive** projects that involve certain types of lighting will receive incentives based on the following rules:

1. Lighting listed by DLC will receive the standard incentive. (You must enter the Product I.D. Number on the Application in the field provided.)
2. Lighting not listed by DLC, but meeting DLC performance criteria, may receive the standard incentive after review of this form. (You must complete this form for each equipment type and submit it with your Reservation Application, if required.)
3. Lighting that is not listed and does not meet DLC performance criteria will receive half the standard incentive. Such equipment must be entered in the appropriate fields on the Application.

**Custom** projects that involve certain types of lighting will receive incentives based on the following rules:

1. Lighting listed by DLC will receive the standard incentive rate per kWh reduced. (The Product I.D. must be entered in the "After Retrofit" field for each installed item.)
2. Lighting not listed by DLC, but meeting DLC performance criteria, may receive half the standard incentive rate per kWh reduced after review of this form. (You must complete this form for each equipment type and submit it with your Reservation Application, if required.)
3. Lighting that is not listed and does not meet DLC performance criteria is ineligible for DTE incentives.

These LED products are not eligible for incentives through the **Energy Efficiency Program for Business**:

- Screw-in LED products
- Any products that receive an incentive through the DTE Lighting Instant Discount Program ([dteenergy.com/savenow](http://dteenergy.com/savenow))
