2018 PROGRAM SUMMARY



PROGRAM HIGHLIGHTS

The 2018 Program Year rolled out on Dec. 1, 2017, and features a number of changes in measure specifications and incentive levels due to new Michigan energy legislation that was introduced in early 2017.

Prescriptive Incentives

Nearly all natural gas and electric prescriptive incentives were reduced by approximately 20 percent. **Custom Incentives**

Custom incentives were reduced to \$0.05/kWh for electric projects and to \$3.50/Mcf for gas projects.

New Construction Incentives

Incentives for New Construction and Major Renovation projects were changed for the interior lighting power density measures, as were the three levels of LEED Whole Building incentives.

DLC lighting

For 2018, only DLC-listed lighting is eligible for Prescriptive and/or Custom incentives.

However, if lighting for a project is from a **category** not listed by the DesignLights Consortium[®] you may complete a Non-DLC Category Product Approval Form to have the equipment reviewed for incentive eligibility.

This form must be attached to the Reservation Application, along with equipment specifications.

Food Service

For 2018, all electric and gas food service cooking equipment has been removed from our program Application and is now available only through the **Food Service Instant Rebate Program.**

The 2018 Program Year application period begins Dec. 1, 2017; and ends Nov. 30, 2018.

•No Reservations will be extended beyond Nov. 30, 2018.

•A project must be completed within 90 days of the Reservation date on your Reservation letter (if applicable).

•Final Applications must be submitted within 60 days of project completion or Nov. 30, whichever comes first.

•Incomplete Final Applications may be subject to cancellation.

•Any Application submitted after Nov. 30 may be cancelled.

NEW THIS YEAR

New 3rd Party & Landlord Agreements - Only Designated Trade Allies (DTA) are eligible to receive assigned incentive payments authorized by a DTE Account Holder.

The program also offers a way for landlords the authorized DTE Account Holder — to assign incentive payments for facility upgrades to a specific tenant. To assign payment, the landlord must first request a Tenant Payment

Authorization Form .

The form must be completed and signed by the DTE Account Holder and attached to the Final Application, along with the tenant's company W9. If not attached, these documents must be submitted within five business days. Failure to follow these steps or if the tenant is ineligible, the incentive payment will be made payable to the DTE Account Holder.

TRADE ALLY TRAININGS

2018 Designated Trade Ally Training will be offered every Thursday in February, and will shift to the second Thursday of every month, starting in March. This training is for contractors who want to renew their status or want to receive the designation for the first time and gain access to our additional Program features. This designation is especially important for 2018, because one of the major policy changes to the Program will be restricting third-party payments only to Designated Trade Allies.
