The ComEd Home Heating and Cooling offering provides residential customers with easier ways to invest in efficient heating and cooling equipment and save on energy costs for their home. Homeowners are eligible for incentives on qualifying products.

Transaction date must be complete, accurate and submitted via the DNV web tool within 60 days of installation.

### Eligibility & Installation Requirements

- Incentives are available for new systems installed in an existing home, new addition or new construction.
- Must have an AHRI system certification of the outdoor unit (condenser), indoor unit (evaporator coil) and where applicable, furnace (air handler).
- If the AHRI certificate validates the system at an efficiency level less than the minimum requirements listed in the charts above, your system is not eligible for an incentive.
- Must be installed in a single-family home or multi-family property with each unit on a ComEd residential rate class. Each residence must have a dedicated heating and cooling system.
- More than one qualifying system can be installed on a single ComEd residential account, however each system may only provide heating and or cooling for a single residence.

 Systems listed as "Variable-Speed Mini-Split and Multi-Split Heat Pumps" in AHRI must have the indoor type listed as "Mini-Splits (Ducted)" or "Ducted Indoor Units" in order to receive the \$1,200 or \$1,400 incentive.

### Additional Program Requirements

Distributors must be an authorized seller of eligible products to participate. All products submitted for reimbursement in the Program must be purchased directly from the manufacturer or manufacturer representative. Transactions must be submitted within 60 days of installation. Distributor must inform all participants that ComEd and third party evaluators will do QA/QCs throughout the year and may reach out to contractors and/or residential customers for additional verification.
