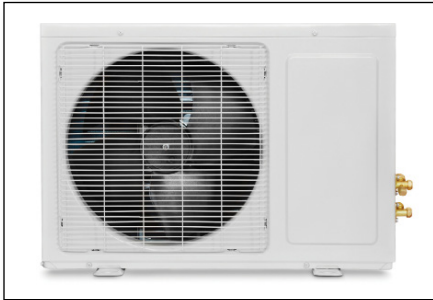


Heating and Cooling Discounts

2024 Eligibility Catalog



Air Source and Centrally Ducted Mini-Split Heat Pumps

≥ 17 SEER2, ≥ 9.4 EER2, ≥ 8.5 HSPF2 air source heat pump discount – Up to \$1,400

≥ 15.2 SEER2, ≥ 9.4 EER2, ≥ 8.1 HSPF2 air source heat pump discount – Up to \$1,200

Eligibility

- The indoor (evaporator coil) and outdoor (condenser) combination, in addition to the furnace, must be AHRI certified validating that the system meets the minimum SEER2/EER2/HSPF2 requirements above. The AHRI certified reference number must be entered in the discount application
- The SEER2/EER2/HSPF2 of the qualifying product including the furnace must meet the minimum efficiency requirements. If the indoor unit, outdoor unit and furnace are not rated together by AHRI, you will need to verify the overall rating of the new system
- Discount is available for a new system installed in an existing home, new addition or new construction

Installation Requirements

- Installations must meet the minimum efficiency requirements as shown above to qualify for a discount. The SEER2/EER2/HSPF2 rating from the AHRI certificate will be used to calculate the discount amount (SEER2/EER2/HSPF2 ratings cannot be rounded up). If the AHRI certificate validates the system at a SEER2/EER2/HSPF2 less than the minimum requirement, your system is not eligible for a discount
- System must be installed in a single-family home (detached or attached, which includes condos, duplexes and townhomes) or a multi-family property with each unit on a ComEd residential rate class

Variable Speed Mini-Split and Multi-Split Heat Pumps

- Systems listed as “Variable-Speed Mini-Split and Multi-Split Heat Pumps” in AHRI must have the indoor type listed as “Mini-Splits (Ducted)” or “Ducted Indoor Units” in order to receive the \$1,400 or \$1,200 incentive

Ductless and Mixed Use Mini-Split Heat Pumps

≥ 17 SEER2, ≥ 9.4 EER2 and 10 HSPF2 mini-split heat pump discount - **Up to \$1,000**

Eligibility

- Discount is available for a new system installed in an existing home, new addition or new construction
- The indoor and outdoor combination must be AHRI certified validating that the system meets the minimum SEER2, EER2 and HSPF2 requirements above
- The discount amount is determined by the SEER rating and HSPF as listed in the program guide. The discount amount is for the complete system, including both the indoor and outdoor units. The actual SEER2, EER2 and HSPF2 from the AHRI certificate will be used to calculate the discount amount (SEER2, EER2 and HSPF2 ratings cannot be rounded up)

Installation Requirements

- Installations must meet the minimum efficiency requirements as shown above to qualify for a discount
- The ductless mini-split heat pump (“system”) must have a SEER2 rating of 17 or greater, EER2 of 9.4 or greater and a Heating Seasonal Performance Factor (HSPF2) of 10 to qualify for a discount, which requires an AHRI certification of the outdoor unit (condenser) and indoor unit (evaporator coil). If the AHRI certificate validates the system at a SEER2 less than the minimum requirement, your system is not eligible for a discount
- System must be installed in a single-family home (detached or attached, which includes condos, duplexes and townhomes) or multi-family property with each unit on a ComEd residential rate class. Each residential home or unit must have a dedicated heating and cooling system (central heating and/or cooling for multiple units in a multi-family property do not qualify)

Mixed Duct and Non-Ducted Indoor Units

- Variable-Speed Mini-Split and Multi-Split Heat Pumps that aren’t listed as Mini-Split (Ducted) or Ducted Indoor Units in the AHRI qualify for up to \$1,000 in incentives and do not qualify for the incentives listed under Air Source Heat Pump (centrally ducted)
