

2020 Measure Bonus Incentives

Exterior Lighting Bonus

In an effort to quickly and safely boost Michigan's economy, the program is offering an Exterior LED Lighting bonus, which can be implemented while practicing social distancing. The program is raising the current \$0.25 incentive to \$0.70 per watt reduced. The program is also lifting the 75% incentive pay cap to 90% of the total cost for this bonus only. This bonus is effective April 27, 2020 and will continue until funds are exhausted. Check with an energy advisor on the status of funds.

2020 Measure Bonus Incentives

These bonuses are capped at 75% of the project cost.

 - 2020 bonus incentives will be altered if/when the program energy savings goals are achieved, as determined within the sole discretion of Consumers Energy.
 - New Pre-Application and new Final Applications must be received on and/or after April 27, 2020 for the bonus on exterior lighting to be included in the 2020 bonus incentives payout.
