Program Funding update



2014 Program funding is available and we will be actively promoting special offers throughout the year, many of which will have their own Applications or worksheets, as well as separate deadlines, so make sure to

check the submission dates.

New Multi-Measure Bonus option offers discounted loan

For a limited time, Michigan Saves is offering a special 2.99% interest rate on financing for projects that qualify for DTE's Energy Efficiency Program for Business Multi-Measure Bonus.

To receive 2.99% financing, a customer must submit an Application through our program with more than one category of energy efficiency measures in which no single category is more than 75% of the total value of the Application.



To get started, find a Michigan Saves authorized contractor to get an estimate on qualifying energy improvements. To find a contractor, visit michigansaves.org. We have new requirements for Custom project calculations

In completing your 2014 Custom Application worksheets you need to:

- 1. Enter the hours of operation per week,
- 2. Enter the number of operational weeks per year,
- 3. Enter the number of days during the year your equipment will not be in operation,
- 4. Enter to the kilowatts of the equipment -- not just the kilowatt hours and
- 5. Check the box as to whether your "After-Retrofit" equipment will be in operation between the hours of 3-6 p.m., Monday-Thursday during the month of July.

NOTE: Items 3 and 4 are new for 2014.

Building Operator Certification tuition reimbursement offered

DTE Energy — in partnership with the Michigan Energy Office, Consumers Energy and the Lansing Board of Water and Light — now offers tuition reimbursement of up to \$950 for Building Operator Certification training.

Only DTE customers with facilities larger than 50,000 square feet are eligible to participate in the tuition reimbursement program. To be reimbursed, a building professional must attend, pass and become certified in the Level I or Level II certification course administered by the Midwest Energy Efficiency Alliance (MEEA).

Multi-Year, Large Custom Gas Project incentive offer

DTE Energy is offering a limited-time special Multi-Year Large Gas Project incentive program to encourage more natural gas customers to participate in the Energy Efficiency Program for Business -- in particular, those that can complete projects with at least 25,000 Mcf in annual energy savings. Under this offer, projects that save between 25,000 and 50,000 Mcf will receive \$4 per Mcf in incentives; for projects involving savings of 50,000 or







more Mcf, customers will receive \$5 per Mcf. The offer also increase the

incentive caps to 100% of the total project costs per Application, and increases the customer cap to \$400,000.

As a Trade Ally who may be working with our natural gas customers, you are encouraged to bring this offer to the attention of your clients and explore possible qualifying projects.
