The Business Energy Services Team (BEST) program is offered to smalland medium-sized businesses located in select cities in the East Bay Area. The primary focus of this program is to help businesses reduce their electricity cost by increasing their facility's energy efficiency. The BEST program promotes the installation and use of cost-effective, highefficiency lighting, refrigeration, and customized technologies through program incentives. Customers may sign up to participate beginning in January 2016. All projects must be installed by October 31, 2016 to be eligible to receive an incentive.

Incentives will be awarded on a first-come, first-served basis and only while funding lasts.

What does BEST offer?

The BEST program offers education, services, incentives, and support to help small- and medium-sized businesses reduce energy usage and lower their energy costs. Our team will evaluate your business' energy use, provide a customized analysis of your facility, and refer your project to a qualified contractor to install high-quality, energy-efficient equipment.

Incentives average 50-75% of the total project cost. In some cases, incentives may even cover 100% of the project cost for the installation of approved technologies.*



Program benefits

- Receive a no-cost, noobligation facility assessment to identify potential energy saving opportunities.
- 2. Get recommendations and estimates of energy savings, project cost, payback period, and the incentive amount to be paid by the BEST program.
- **3.** Approved energy saving equipment is installed by a local, pre-qualified contractor.
- Pre- and post-installation inspections assure quality and verify energy savings.
- Receive potential cost reductions on your energy bill.
- **6.** Experience average payback of less than three years.

*Incentive percentages, actual savings, and payback periods will vary depending on the energy-efficient equipment installed, building construction, customer operation, age of existing equipment, location, and other parameters, specific to the project.
