# Trade Ally Feedback We respond to your comments from monthly surveys

**Comment:** Get rid of the hours [of use] aspect of the application. Base it off watts reduced. Copy Consumers [Energy] application and their incentive rates.

Response: While we appreciate your note to base lighting incentives on watts reduced only, this does not accurately reflect the typical energy savings for each facility. Since 2021, the DTE Energy Efficiency Program for Business has implemented a more accurate way to determine energy savings and associated incentives for interior lighting projects based on two key variables: 1) watts reduced and 2) hours of use. This allows DTE customers to receive incentives that appropriately correspond to one of the following tiers of lighting hours:

#### **LED** lighting, shift operation (reservation required)

Equipment type	Hours/week	Unit
LED lighting, 1-shift operation	1 - 65	Kilowatts reduced
LED lighting, 2-shift operation	66 - 115	Kilowatts reduced
LED lighting, 3-shift operation	116 - 167	Kilowatts reduced
LED lighting, 24/7 operation	168	Kilowatts reduced
