Application overview

DTE Energy is offering energy efficiency incentives to agricultural customers interested in upgrading to more energy-efficient equipment as part of the DTE Energy Efficiency Program for Business.

Agriculture customers – including those on both residential and commercial rate codes – have access to a special list of energy efficiency measures designed specifically to meet the needs of the farming, dairy and greenhouse communities. These incentives are available only to commercial rate and residential rate customers whose primary source of income is from agricultural operations and activities.

Incentives available through this program are limited by customer for each program year (see table at right): only DTE electric customers may apply for electric incentives; only DTE gas customers may apply for gas incentives. Those customers who receive both electric and gas service from DTE may apply for all incentives.

Who can apply?

You must be a DTE electric and/or natural gas customer in good standing. Your project must be installed at a facility served by DTE.

- A customer is defined as the owner of the farming operations, with a unique taxpayer ID number, that is responsible for the DTE bill for one or more facilities.
- A project is defined as a unique energy efficiency measure or set of measures implemented at a facility in a single time span.
- A facility is defined as a Michigan farm and its complex of buildings on a single contiguous property or individual single family dwellings. Each may have its own or be on a single meter that receives a residential rate. A single customer must be responsible for paying the DTE (electric and/or natural gas) bill for this/these meter(s).

Installed equipment must meet the specifications explained in this application.

Reservation of funds

To make things easy, all you need to do is complete all the forms on an electronic version of this application and click the “email application” button on page 5. Reservations are strongly encouraged – and in some instances required – so that we can set aside funds for your project.

Installation

Complete your project within 90 days of your reservation letter or by Nov. 30, 2021, whichever comes first.

Inspections

DTE reserves the right to inspect all projects to verify compliance with program rules and verify the accuracy of project documentation. This may include pre-installation and/or post-installation inspections. Detailed lighting layout descriptions, metering, data collection, interviews and other information may be requested as appropriate.

Final application (project completion)

Just like with the reservation application, you can also electronically submit your final application when your project is finished, or you can email, mail or fax it. Don't forget to attach all required documentation (including dated, itemized invoices and manufacturer specification sheets). The final application must be signed by the DTE account holder and submitted within 60 days of project completion or by Nov. 30, 2021, whichever comes first. Applications submitted after that date will be canceled.
