# 2020 Large project program

## PROGRAM OVERVIEW

With the 2020 large project bonus program, the DTE Energy Efficiency Program for Business seeks to reward designated trade allies for their dedicated work on large projects.

Between Feb. 1, 2020 and Nov. 30, 2020, eligible designated trade allies can receive a 10% bonus on measures for submitting complete paid final applications for electric or gas projects that result in a paid incentive per measure category of at least \$9,100. Bonus is capped at \$10,000. All final applications must be submitted by Nov. 30, 2020 to be eligible for the bonus. Large project bonuses are calculated according to paid incentives per measure category.

Bonus dollars will be paid per application, with a check payable to each designated trade ally. Any final application submitted by a trade ally prior to Feb. 1, 2020 or after Nov. 30, 2020 will not qualify for a reward. Any projects previously applied for and cancelled will not qualify for a reward.

## COMPLIANCE WITH DTE PROGRAM REQUIREMENTS

Participants in the 2020 large project bonus program shall comply with all requirements, terms and conditions of the DTE Energy Efficiency Program for Business, as set forth in the incentive applications and related program documents.

## ELIGIBILITY

Eligible participants in the 2020 large project bonus program must:

- Be a designated trade ally in good standing on the date of enrollment and remain in good standing throughout the 2020 program year
- Submit a completed large project bonus program application (reverse side) to: [saveenergy@dteenergy.com](mailto:saveenergy@dteenergy.com)
- Reservation and final applications submitted prior to completing the program enrollment application will not be eligible for the large project bonus
- Trade allies who are not able to receive third party incentive checks are not eligible to participate in the large project bonus program

## REWARD REQUIREMENTS

The following requirements must be met before a reservation application (when applicable) and final application can qualify for a DTE large project bonus:

- The reservation application and final application must include all required documentation, information and signatures at the time of submittal
- The reservation application and final application must be filled out and submitted by the designated trade ally, from the designated trade ally's email address, fax number or return address
- The designated trade ally's information must be listed in the "primary contractor/distributor information" field on the final application
- The final application must result in a paid project
- Reservation applications must be submitted and reserved before final applications are submitted
- For applications submitted through the online tool, indicate "large project bonus" in the notes section on the validate tab

Incomplete applications and applications submitted directly by customers or subcontractors will not qualify for a large project bonus.

The 2020 large project bonus program may be combined with other DTE Energy Efficiency Program for Business bonus programs. However, large project bonus program incentives are calculated from the paid base incentive total, which does not include eligible bonuses. Funds are limited and subject to change. This offer may end at any time.

\* Each measure category (electric or gas) must be \$9,100 and cannot be combined with other categories. Please note, the following measures do not qualify for the large project bonus:

- Building operator certifications
- Compressed air audit with leak repair measures (CA-25, CA-41)
- HVAC tune-up measures (HE-48, HE-49, HE-50)
- Refrigerated savings due to lighting savings measures (FE-35, FE-36, FE-37)
- Boiler tune-up measures (HG-21 through HG-28)
- Furnace tune-up measures (HG-29 through HG-31)
- Process furnace/burner tune-up measures (HG-42 through HG-45)
