Welcome to the 2023 program year!

Overview

The 2023 program year features major changes in electric incentives across the board.

Incentive change highlights

Custom electric updated from \$0.05 to \$0.08 per kWh

- (L-1) Interior LED, 1-shift updated from \$145 to \$180 per Watt reduced
- (L-2) Interior LED, 2-shift updated from \$225 to \$300 per Watt reduced
- (L-3) Interior LED, 3-shift updated from \$400 to \$550 per Watt reduced
- (L-4) Interior and exterior LED, 24/7 updated from \$425 to \$600 per Watt reduced

(HE-50) Chiller tune-ups updated from \$3 to \$7 per ton

- (PE-98 to PE-109) Computer room hot aisle cold aisle configuration, 5/10°F return air increase, air/water/glycol cooled
- (PE-110 to PE-118) CRAC Economizer, air/water/glycol cooled

- (ME-11 to ME-15) Laminar flow restrictor (electric)
- (WG-19 to WG-23) Laminar flow restrictor (gas)

Measures replaced

(PE-28 to PE-30, PE-51 to PE-53, PE-60 to PE-62) CRAC unit measures have been replaced with measures PE-98 to PE-127

(HE-19 to HE-22) Ground Source Heat Pump measures have been replaced with Ground Loop Heat Pump measures HE-71 to HE-74

Measure changes

Interior LED measures L-1 through L-4 can now include any change in fixture quantity for a given space. Previously, any change in fixture quantity could warrant a custom lighting measure. This new approach eliminates the need to submit custom lighting applications except for unique circumstances (e.g., LED modules for outdoor advertising). Additionally, lighting power density (LPD) measures can be submitted as custom with proper measurement and verification (M&V) of lighting hours of use.

2023 important dates

The 2023 program year application period:
January 1, 2023 - November 30, 2023

- No reservations will be extended beyond November 30, 2023
- A project must be completed within 90 days of the reservation date on your reservation letter (if applicable). Requested extensions will be evaluated by program staff.
- Final applications must be submitted within 60 days of project completion or November 30, whichever comes first
- Incomplete final applications may be subject to cancellation
- Any application submitted after November 30, 2023 may be cancelled
