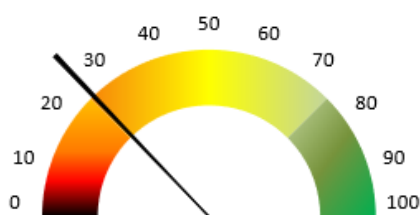

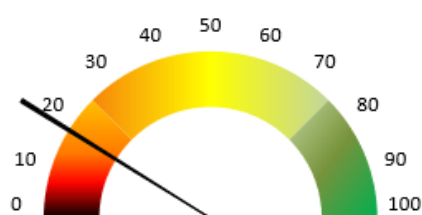

In an effort to quickly and safely boost your business and lower our customers' energy costs, we are offering a huge Exterior LED Lighting bonus, a measure that can be implemented while practicing social distancing.

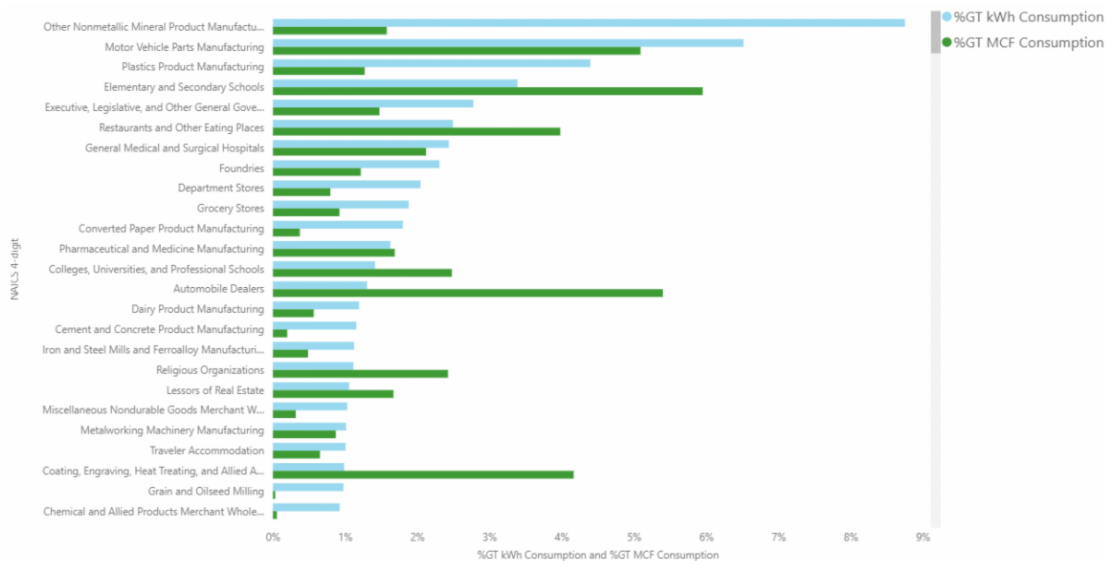
